# **Heirs' Property**

Twenty states have enacted a law, called the <u>Uniform Partition of Heirs Property Act</u>, that helps to protect heirs' property owners from a forced sale. The District of Columbia and the US Virgin Islands have also just enacted heirs' property and three other states have introduced an heirs' property bill. At the federal level, USDA provided \$67 million in 2022 for owners of heirs' property, which can be used to clear their titles by buying out other heirs' shares of the land, or for legal, appraisal, and other fees associated with title reconciliation.
